NFU Hedges Competition Terms and Conditions

NFU Pledge for net zero: Win 100 metres of hedgerow plants prize draw

The competition is open to residents of United Kingdom only, excluding NFU employees, their families, agents or anyone else professionally connected with this promotion.

Entry to this prize draw is free.

Entrants must be 18 years or over and must be current NFU members.

Members are permitted to submit one entry per membership.

In order to enter participants must:

- 1. Click on the following link at We're in for net zero #Pledge2040 (nfuonline.com)and complete the form to make a 'We're in for net zero' pledge.
- 2. Take a short (no more than 60 seconds) video, or image and caption. The video or image and caption must describe why hedgerows are important for net zero. Post the video or image and caption, with #Pledge2040 and #MOREhedges, to as many of your social channels as you can, but it must include as a minimum a twitter account.
- 3. Email your video or image and caption, with your email and membership number to netzero@nfu.org.uk.
- The draw will be made from all submissions posted and emailed between 8am on 29 May and midnight on 16 July 2021.

- The prize consists of 100 metres of hedgerow plants supplied by the Woodland Trust. The 100m of hedging will be delivered during tree planting season, between November 2021 and March 2022. The exact time frames will be confirmed to you via email by the Woodland Trust. A mix of species will be supplied to plant five shrubs per metre as a double row hedge. About half the mix will be made up of hawthorn, and the rest will comprise a range of species such as blackthorn, hazel, field maple, dog rose, dogwood and crab apple. The Woodland Trust will also provide 25 oak saplings which will go on to become the next generation of hedgerow trees. Shrubs will be provided with spiral guards and canes for protection, while the 25 trees will come with 1.2m tubes and 1.5m stakes. The Woodland Trust is solely responsible for the fulfilment of the prize. By entering you give permission for the Woodland Trust to contact you over fulfilment.
- The prize will be awarded to the first entrant to be randomly selected from all valid submissions by a member of the NFU net zero team whose decision is final. No correspondence will be entered into regarding the selection of the winners.
- The prize is non-transferable and there is no cash alternative.
- The NFU will notify the winner by email before the end of August 2021.

- Please note, we are required to make the name and county of residence of the winner available publicly. We may also ask you to take part in additional publicity connected with this prize draw.
