17.04.2023	The North West Region proposes that the premature curtailment of badger culling by Defra, years before their alternative control tools are ready to be deployed widely across England, nor proven to be as effective as culling, will result in failure to eradicate Bovine TB by 2038. Hence the NFU should do more to challenge Defra to prolong Supplementary and maintenance culling until then.	NW	Addressed	The resolution was discussed and agreed as in line with NFU BTB policy. 13.04.2023	The East Anglian Regional Board fully recognises the need to review the NFU structure and organisation to ensure it is fit for purpose in representing members interests. It is however vital that sector boards continue to be predominantly elected representatives of their members. This is a core principle of the NFU. We propose that in the new structure, with a smaller number of regions, that those regions with a greater number of members in a particular sector eg combinable crops or livestock should have additional representation on the national board - if not directly elected, then by means of the appointment process; but with the proviso that this person should be nominated by 20 or more members from that region AND who are active in that sector. 22.01.2024	The South Regional Board ask Council to consider the following amendment to the NFU standing orders: When a regional sector/commodity board chair is appointed to a national sector/commodity board chair, that their role on the regional commodity/sector board can be deputised by their elected vice chair who would then automatically take a place on the National board as one of the regional representatives. For clarity following this change, where the regional sector board chair becomes the national chair and choses to deputise the regional role, the regions' 2 representatives on the national board will be filled by the elected vice chair (with voting rights) and 1 additional representative (appointee – nonvoting). This amendment allows the Chair to prioritise national concerns whilst maintaining full regional representation and thus alleviating time and work pressures for the national sector/commodity board chair. We therefore ask that the role be opened up to include a member from the region who has the required skill set, rather than limited to Regional Board members, much like the commodity boards will be seeking members with specific qualities to gain the required skill set for their boards.
