



DEVELOPMENT OF APPROVED ACTIVE SUBSTANCES








### Cabbage Stem Flea Beetle 2015/2016



#### March 2015

- Increase from 24.39 mT to 31 mT GTW
- Increase in speed to 40 kph
- NO additional testing required

#### Future developments

- Possible increase to 35 & 39 mt for 2 and 3 axle trailers
- Appropriate vehicle testing requirement to run at increased weights
- Implementation unlikely before harvest 2017



UK and international nitrogen fertiliser prices, £ Sterling, 2000-2015






