What you can expect

The NFU offers you an exciting, quality training scheme within the NFU's Legal Affairs Team. The Legal Affairs Team is a small, busy legal team. We are committed to providing high quality legal advice to the NFU's Officeholders and Directors and staff across the country, as well as providing legal support to the NFU's farmer and grower members. You'll be working in a unique, fast-paced environment where variety is paramount.

The Legal Affairs Team provides advice on a variety of issues and the last six months have seen the Team involved in the following:

- Litigation in the Supreme Court as an Intervener in a high profile case concerning meat processing. The team manged the intervention in-house with assistance from Counsel.
- Pursuing litigation in the European Court of Justice as an Intervener in two high profile cases concerning plant protection products.
- Advising internal clients on industry supply contracts.
- Providing legal advice and support to members on a number of industry insolvencies.
- Providing legal advice to internal clients on a wide range of environmental issues.
- Advising on a significant breach of contract claim with serious implications for NFU members.
- Advising internal clients on the legal aspects of "Brexit" and international trade.

Where you will go?

We want to provide our Trainee Solicitors with a tailored comprehensive legal training, and a detailed understanding of the industry. We will provide you with experience of as many areas of the organisation as possible. This is likely to include some travel to our offices throughout England, Wales and possibly Brussels, including overnight trips. Farm visits and member meetings are also likely to be included as part of your training experience, to provide you with a greater understanding of the agricultural industry and the needs and requirements of our members (see below). You will also benefit from a secondment of up to 3 months with one of our panel firms of Solicitors.

What will you experience?

Your comprehensive training will encompass all of the Solicitors Regulation Authority Practice Skills Standards and will provide an excellent grounding for qualification as a Solicitor. Your training will include the following:

- A variety of experience through individual assignments, research and team project work with other technical specialists within the NFU.
- Attendance on and completion of the Professional Skills Course.
- A placement of up to 3 months with one of the NFU panel firms of Solicitors. During this placement you will focus on litigation and ADR.
- Access to a relocation fund, to make moves between placements easier (where moves are required).
- Full support and guidance whilst on placement with access to a dedicated Training Principal, as well as other qualified solicitors within the NFU Legal Affairs Team.

During your 2 year training programme you will have exposure to and develop an understanding of many of the following areas of law:

- Company
- Media
- Contracts
- Tort
- Competition
- Property
- Regulatory
- Environment
- Employment
- Animals / Animal Health
- Administrative / Public
- Agricultural Payment Schemes
- Insolvency
- Rights of Way and Commons

How we will support you

The NFU's Senior Legal Adviser will be your Training Principal, and will organise and support you through the 2 year scheme. In addition to this, you will have the benefit of day to day support and guidance from other qualified Solicitors within the Legal Affairs Team who may require you to carry out assignments, or work on projects with them.

You will also have access to a £2,000 relocation fund, in addition to a starting salary of £24,500 per annum. This relocation fund is specifically on offer to provide some help if we require you to relocate temporarily for your secondment. This may not be required, but where you do need to move, the fund will help with the cost of house-hunting, short-term accommodation (it is not designed to cover rent) and travel expenses. You should note the fund is available as and when required, and would be made available at the time of need against a specific claim.

As a welcome to the NFU you will receive a one off Trainee Solicitor entry scheme payment of £1.000.
