



NFU Renault offer

Terms and Conditions

- 1. This programme is available to NFU Farmer and Grower members only, which meet the following criteria:
 - i. Be an NFU Farmer and Grower member, Partner (provided they are linked to an F&G record), NFU Retired
 - ii. Have maintained 14 months of continuous membership at point of request, and
 - iii. Have made a minimum of 14 months subscription payment with a Direct Debit instruction set up for the current membership year if paying by Direct Debit or have made a minimum of 14 months subscription payment and in addition, have paid in full for the current membership year at the point of request, subject to NFU discretion, if a cash payer.
 - iv. In addition, NFU Partner memberships must be linked to a valid NFU Farmer & Grower membership to be eligible.
- 2. This programme is not available to any other NFU membership categories or any member that does not meet the eligibility criteria, as set out in Point 1.
- 3. Eligible members are allowed a maximum of 2 vehicle vouchers per membership annum (For the avoidance of doubt, a year constitutes 1st November 31st October). This applies across all NFU vehicle partners and is not per manufacturer. However, requests for additional volume will be considered on an exceptional basis.
- 4. A voucher is valid for 30 days and must be presented to an authorised Renault dealer at the point at which you order the vehicle and this must be before the expiry date shown.
- 5. A voucher is invalid if:
 - i. The name and address on the voucher does not match the name and address on the dealer invoice, or
 - ii. It is presented to an authorised Renault dealer after the expiry date.
- 6. The NFU discounts have been negotiated with the supplying retailer and Renault UK and will be deducted by the supplying dealer from the from the basic price (before VAT, delivery and On The Road charges).
- 7. The NFU discount applies to the basic retail price of the vehicle only and does not apply to metallic paint, parts, accessories or servicing.
- 8. The NFU discount applies to retail sales in the UK mainland and Northern Ireland.
- 9. The NFU discount available on standard models only (limited editions and special editions excluded) and purchase is subject to the availability of the vehicle type and model.
- 10. NFU member discount cannot be used in conjunction with any other Renault retail offer, fleet offer, discount or promotion.
- 11. Contract hire sales are excluded from this offer.
- 12. Proof of membership and qualification for NFU discount must be verified in advance of sale.
- 13. Order approval required from NFU prior to vehicle registration.
- 14. The NFU discount vouchers are non-transferrable and have no cash value.
- 15. The vehicle(s) must be registered in the members name at the members address. The only exception is in the case of a vehicle being registered in the name of a business (limited company, sole trader or partnership).
- 16. The vehicle(s) must remain in the member's name for a minimum of 12 months (DVLA keeper change audits will be monitored).
- 17. The NFU or Renault may change the terms and conditions, including the availability of the deal at any time and without notice.
