### MAY'S COMMITMENT TO BRITISH FOOD AND FARMING

This week Prime Minister Theresa May stated she 'will continue to back British farmers' post-Brexit. In her answer to Victoria Atkins MP, Louth and Horncastle, during Prime Minister's Questions, she said: "We do have an opportunity to build a new future for our food & farming industry when we leave the European Union. We will maintain the UK's high standards of food safety and of animal welfare, that will be a priority for us and any trade deals we enter into will need to be right for consumers, for businesses, for farmers they will need to ensure our food safety and environmental protection and of course the animal welfare standards I just referred to. We recognise the need for certainty for businesses and we've already provided guarantees of support for farmers up to 2020 and I can assure her we will continue to back British farmers.

Three Lincolnshire MPs contributed to the debate with apologies from Victoria Atkins MP (Louth & Horncastle). Brandon Lewis mentioned his meeting in Lincolnshire farmers who have suffered due to Hare Coursing on their farms and a further MP name-checked the NFU. ## LIVESTOCK FARMERS URGED TO POST-MORTEM SUSPECTED CASES OF SCHMALLENBERG DISEASE

Some lamb producers Lambing flocks across the country have experienced higher than normal losses from deformed lambs with the disease so far confirmed in the South West, South East, Wales and the North East. Early calving herds have also experienced calves with congenital defects. We have heard about cases on the Leicestershire/ Warwickshire boarder in early lambing flocks. Any infection present on farm now will have taken place last year and there is nothing that can be done to alleviate issues at the moment. Livestock producers may want to undertake SBV testing of any suspected cases, and should talk to their vet. While post mortems on whole carcasses are chargeable by APHA, we understand that APHA brain samples tests are free.

Nottinghamshire County Council will be carrying out a cultivation and cropping survey across the county starting on April 3. The County Council has warned that "If it is necessary to resort to enforcement action, the breach of GAEC 8 may be reported to the Rural Payments Agency." Please ensure public rights of way across arable fields are not only delineated but also have the crop mown on the path or sprayed out.
