The EU Commission has voted to revoke the use of the molluscicide methiocarb in slug pellets, due to their risk on none target grain-eating farm birds. Read the NFU briefing here.

We will continue to work with the DfT to demonstrate the need for change.

Legal Clarification on feeding calves

The NFU recently commented on a series of questions from the Farm Animal Welfare Committee on the role played by nutrition, on optimising the health and welfare of artificially reared calves originating from the dairy herd, with a focus on the timeframe from birth to weaning. These questions explored the dairy industry's use of 'once a day feeding' regimes for young calves — a controversial and potentially illegal management practice (dependent on the age of the animals). NADIS (National Animal Disease Information Service) produces advanced training for on-farm disease recognition.



Parasite forecast: Liver fluke – chronic weight loss despite adequate feeding This February's Parasite Forecast outlines the parasitic challenge facing cattle and sheep in the different regions of the UK including liver fluke forecast and advice especially in breeding ewes and out-wintered cattle, continuing risk of PGE in store lambs and replacements and lice in sheep.



<u>Disease Alert:</u> *Dairy Fertility*

In addition, NADIS publishes a monthly **Disease Alert** which brings attention to key diseases. One of the most costly issues for dairy farmers is that of poor fertility, and one of the main contributing factors is delayed calving to first service. In this webinar James Aitken BSc BVetMed MRCVS, of Orchard Veterinary Group Glastonbury discusses anoestrus in cows as well as factors important in maximising new-born lamb survival.

Agri-Food Advanced Training Partnership

Members are reminded that skills and training courses are available to businesses in the Agrifood sector through the Agrifood Advanced Training Partnership. This is one of four higher level training partnerships that have been awarded funding by the BBSRC. Training is delivered by four leading recognised university and research institutes: The University of Nottingham; Harper Adams University; Cranfield University and Rothemsted Research. Training is delivered in short courses and through e-learning, and can be anything from one day workshops and field days to short courses and accredited postgraduate programmes. If you are currently employed in a UK based company in the Agrifood sector, you may also be eligible for a bursary to cover 100% of the fee of the course.
